#### **ORDINANCE NO. 2025.017**

# DECLARING A NECESSITY FOR AND AUTHORIZING THE TRANSFER OF \$500,000.00 FROM THE ELECTRIC FUND TO THE WATER FUND OF THE VILLAGE OF BLANCHESTER TO COMPLY WITH THE REQUEST OF THE BOARD OF TRUSTEES OF THE PUBLIC AFFAIRS

WHEREAS, Council has given due consideration to the necessity for future standing operating procedures of the Village of Blanchester which is under the control of the Board of Public Affairs of said Village; and

WHEREAS, the Board of Trustees of Public Affairs has requested that the Village Council authorize that the transfer of \$500,000.00 be made from said Electric Fund to the Water Fund; and

WHEREAS, it is determined by Council that the ending balance of said Electric Fund for the period ending December 31, 2024, was \$4,424,016.00 and is sufficient to maintain and operate the Electric Fund for the foreseeable future, and that a request for the transfer of \$500,000.00 from the Electric Funds to the Water Fund is reasonable and immediately necessary, same being under construction.

**NOW THEREFORE BE IT RESOLVED,** by the Council of the Village of Blanchester, Clinton County, Ohio:

### Section 1.

The Village Board of Public Affairs Solicitor and the Fiscal Officer of said Village be and they hereby are authorized to prepare a petition to be filed with the Ohio Department of Taxation, requesting an order to secure the approval as required by law, particularly Ohio Revised Code Sections 5705.14, 5705.15, and 5705.16, and that all the required information be submitted to the Ohio Tax Commission for its consideration and approval.

#### Section 2.

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

## Section 3.

This Ordinance is hereby declared to be an emergency measure to ensure the Board of Public Affairs of the Village of Blanchester can continue to provide essential public utilities and meet the operation and maintenance costs of the Village's Water Treatment Plant.
