

# RESOLUTION NO. 2021.026

## RESOLUTION GRANTING FISCAL OFFICER PERMISSION TO UTILIZE ELECTRONIC SIGNATURE CAPABILITIES ON THE UNIFORM ACCOUNTING SYSTEM

**WHEREAS**, The Uniform Accounting Network (hereinafter referred to as "UAN") is a financial software package created by the Auditor of State's office to support the accounting, payroll and financial management activities of local governments in Ohio. UAN, along with computer equipment and technical support provided by the Auditor of State's office, makes it easier for public officials to apply the required accounting standards to their financial record keeping. Currently, more than 2,000 Ohio townships, village, libraries, special districts and cities are using UAN in their daily operations, including the Village of Blanchester; and

**WHEREAS**, UAN provides the ability to print electronic signatures on several transaction, including but not limited to documents such as warrants, vouchers, payroll, and purchase orders; and

**WHEREAS**, the Fiscal Officer for the Village of Blanchester, would like permission to utilize the electronic signature capabilities of UAN with permission of Council; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the Village of Blanchester, Ohio, two-thirds or more of the members elected thereto concurring, that Village of Blanchester Fiscal Officer is hereby given permission to utilize the electronic signature capabilities of the UAN program.
