The chief brought to the committee the need to secure monies to take care of the K-9 for the handler. This would include his cost for keeping and caring for the dog.

Mr. Hopkins wanted to ensure everyone, after the last meeting, Doug Naylor with First National Bank is providing the pledged securities that are required for our deposits, and that everything is insured.

<u>Safety & Service</u> – Mr. Parks reported that they did meet and discussed the crosswalk by BP and the High School. The Chief let the committee know that the body-worn cameras are in and they are being trained on them, also the new speed safety signs were installed.

<u>Cemetery</u> – Paul Daniels reported that he filled in some sink holes and that we are getting a price to take down a pine tree near 28.

Old Business

It was moved by Mr. Hopkins and seconded by Mr. Hill that Choice One is allowed to move forward with a not-to-exceed \$1,000.00 to do a topographical survey to repave 600 ft along SR 28 (Main St.) between Wall and Church St. This would be to remove the underlying brick and build it back up. Curbs and gutters would also be replaced in this area. Mr. Hopkins would like to see a way to save and reuse the brick that is being torn up.

Mr. Hopkins moved, and Mr. Parks seconded to adopt the new curfew per Resolution 2025.011in the Village of Blanchester community parks. Parks would be closed from dusk to dawn.

Discussion Item

The mayor shared what he learned from the Election Board regarding putting a question on the Ballot, to see if voters favored hiring a Village Administrator and dissolving the BPA Board. The cost to the village to have the question placed on the ballot would be between \$5,000-8,000. It was decided that it was not worth the cost to ask a question. The Mayor and the Chairman of the Board of the BPA would like the council to wait until 2030, pending the next census, before considering hiring a Village Administrator.

Department Reports

Solicitor – Nothing to report

Parks – Just finished another successful splash day. Also, reminded of the upcoming Party in the Park, July 14th at 6:00, and a scheduled meeting of the Parks Dept. to discuss the Nature Park.

Police - Chief Houghton went over the June monthly report, including the events the PD has been involved in. Chief also shared that the Cops and Bobbers event was a success. Additional training was done this month. Training is being done with body-worn cameras. A charge of \$75 per hour, not to exceed \$750 for a public record request for the body-worn cameras. A grant has been applied for to hire an SRO (School Resource Officer), but we are waiting on the schools to see what they can do as well. A grant was also submitted for the cost of the flock cameras for the second year.

Street – Paul Daniels, nothing to report.

BPA – James Bowling reported that they did have a meeting at the sewer plant for the community to see what is going on. He expressed his concern that we are dipping into our 6month reserves at the Water Dept.

Zoning/Maintenance – Chris Hilderbrandt nothing to report, but the mayor did report that the painting of the first floor is underway.

Fiscal Officer – Regina Johnson just wanted to let everyone know that the audit is in full swing. A new checking account was opened at Peoples Bank for the Parks & Recreation Department. We are working to get this set up so they can start collecting donations soon.

Mayor – The mayor gave everyone a letter for the Safe Routes to School. We were not chosen this year as a recipient. Wanted to thank the Village of Blanchester Employees. Because of their support, we had a great July 4th.

It was moved by Mr. Hopkins and seconded by Mr. Parks that the meeting be adjourned at 7:50 PM. All agreed to adjourn.
