## **Public Comment**

James Constable - Looking at Auditors website he thought it looked like we were building a new Sewer plant for \$447,000 and asked if so, why, where would it be and what would the cost from the engineering office be for that and a start and completion date. He also noticed \$167,000 was reduced from the Parks Revenue and inquired if that had been a mistake or where it had gone. Mr. Constable also stated that he did not think that we had ever approved the December 29, 2022 meeting minutes and wanted to know why.

Janelle Fatheree - Ms. Fatheree brought up the fact that she had spoken with Mr. Hopkins and she thinks that we should do something to let the community know about the good things that the Council has done. She suggested putting summaries of our projects on the bottom of the utility bills. She spoke of a few examples of things she thinks we should put on the bills and thinks that more people would be more support of the Council. She also suggested putting up short Bios on the Council members and the projects that they are working on. She was returning to the meeting to bring attention again to the issue of cars parking along East Main Street from the 300 block from 301to 309 blocking sight for residence who cannot see cars coming from North High Street. The loss of vision makes backing out of driveway difficult and dangerous. She discussed her conversations with the Chief regarding this issue and he had asked her if she had spoken with the Safety committee at all about the issue and she responded that she did know she needed to so she again is asking for some resolution from Council on the problem.

Elizabeth Nichols and Terri Wolfe – Having an issue with parking on Main Street in front of the Biker Consignment store. That is their only parking for customers and their only place to load and unload items for the store. There is now a tenant who is renting a place down the street who is now parking in the space directly in front of the store every day. They have reached out to this new tenant and asked her politely not to park there during store hours in which she replied she can park there any time that she wants to. They are asking Council to consider a parking sign out in front of the store stating that is for customer of the store parking only during business hours. They asked to hear back from the Mayor regarding this issue.

Doing mock crash at the High School on Friday May 7th the day before the Prom hoping it will help the high schoolers to think about their choices Prom night and every night.

Street -The Phase II Cherry Street should start the week of May 1st. They may be closing down the street.

Zoning – There had finally been a permit issued to Taco Bell and they have been given their ok on their sign. Still just waiting for UDF to tear down the old building so the water and sewer lines can be split from McDonalds.

Fiscal – Nothing to report

Mayor – There will be an employee meeting held on May 2<sup>nd</sup> to discuss Freshbenies a telehealth option that will be discussed with us from our insurance provider that will give you the opportunity to be able to call and talk to a Dr. on the phone instead of having to go to the office or Urgent Care. Mayor reminded Council about the dinner at the Baptist church that we were invited to on April 30<sup>th</sup>. He also discussed a Community Cleanup Day Rumpke will be supplying 2 40-yard dumpsters, one will be at the Municipal building and the other will be at the roadside park. No appliances, Drywall or tires will be permitted. Village will supply the garbage bags if needed. There is signage to be put out with information regarding this cleanup day, we could use all the help we can get. It was suggested that we reach out to the school, girl scouts and boy scouts and ask if they would like to help.
