

ORDINANCE NO. 2024.023

2025 TEMPORARY APPROPRIATIONS

An ORDINANCE to make temporary appropriations for current expenses and other expenditures of the Village of Blanchester, State of Ohio, during the fiscal year ending December 31, 2025.

Section 1: Be it resolved by the Council of the Village of Blanchester, State of Ohio, that, to provide for the current expenses and ordinary expenditures of the said Village of Blanchester during the fiscal year until April 1, 2025, the following sums be and are hereby set aside and appropriated as follows:
Attached Exhibit 2024.023 A.

Section 2: And the Village Fiscal Officer is hereby authorized to draw warrants for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

Section 3: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code; and

Section 4: This Ordinance is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare and safety of the Village. This Ordinance must be passed by emergency due to time constraints.

Section 5. That this Ordinance shall be effective at the earliest date allowed by law.

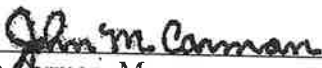
