

RESOLUTION NO. 2018.017

A RESOLUTION DECLARING THE NECESSITY FOR A TRANSFER OF AN AMOUNT NOT TO EXCEED \$50,000.00 FROM WATER REPLACEMENT AND IMPROVEMENT FUND (5701) TO THE WATER BOND RETIREMENT FUND (3103) OF THE VILLAGE IN ACCORDANCE WITH OHIO REVISED CODE §5705.14

WHEREAS, Section 5705.14(A) of the Ohio Revised Code requires that the unexpended balance in a bond fund that is no longer needed for the purpose for which such fund was created shall be transferred to the sinking fund or bond retirement fund from which such bonds are payable; and

WHEREAS, the Water Tower Retirement (Water) Bond Issuer's Documents Bond Legislation section states that "the...Replacement and Improvement Fund shall be maintained in the custody of the Village as trust funds," and "the Replacement and Improvement Fund shall, to the extent necessary from time to time...be transferred to the Bond Account to permit the payment of all obligations payable from such Bond Account..."; and

WHEREAS, it is in the best interest of the Village to transfer the amount of \$50,000.00 from the Water Replacement and Improvement Fund (5701) to the Water Tower Retirement (Water) Fund (3103); and

WHEREAS, such transfer of money constitutes a transfer of funds within the meaning of the Ohio Revised Code Section 5705.14; and

NOW, THEREFORE BE IT RESOLVED BY THE VILLAGE OF BLANCHESTER COUNCIL, CLINTON COUNTY, OHIO THAT:

SECTION I. It is hereby determined to be necessary that the unexpended balance in the Water Replacement and Improvement Fund (5701) in the amount of \$50,000.00 be transferred to the Village of Blanchester's Water Retirement Fund (3103). Monies transferred pursuant to this Resolution shall be used for the reasons such fund has been established.

SECTION II. The Village's Fiscal Officer is hereby authorized and directed to transfer such funds as set forth in Section I.

SECTION III. The Council finds and determines that all formal actions of the Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.
