

RESOLUTION NO. 2026.017

RESOLUTION ESTABLISHING NEW FUND 2913, BUREAU OF WORKERS' COMPENSATION SAFETY GRANT, FOR THE VILLAGE OF BLANCHESTER STREET DEPARTMENT

WHEREAS, Ohio Revised Code Section 5705.09(F) authorizes the establishment of a fund to account for a new grant whose use is restricted to a particular purpose; and

WHEREAS, the Village of Blanchester has received the grant monies to be restricted for the use of the Purchase of Portable Traffic Signals for the Blanchester Street Department, Village of Blanchester, County of Clinton, State of Ohio; and

WHEREAS, the Village of Blanchester is required to establish a new fund to track the use of said monies;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Blanchester, Clinton County, Ohio:

Section 1: The Fiscal Officer of the Village of Blanchester shall establish the following Special Revenue Fund entitled BWC Grant – Portable Traffic Signals using fund number 2913

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including 121.22 of the Ohio Revised Code of the State of Ohio.

Section 3: This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety, and general welfare of the people of this municipality, and shall take effect at the earliest date provided by law. This Ordinance must be passed as an emergency due to time constraints.

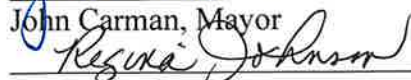
Mr. Parks moved the adoption and Mr. Hopkins seconded the motion, and the roll being called upon its adoption, the vote resulted as follows:
