

RESOLUTION NO. 2024.020

**RESOLUTION DECLARING IT NECESSARY TO ADVANCE \$14,400.00 TO THE H2OHIO RIVERS SALT BIN FUND (4201) FROM THE GENERAL FUND (1000)**

WHEREAS, on August 1, 2024, the Village of Blanchester ("Village") was notified it was selected to receive the H2Ohio River Chloride Reduction Grant;

WHEREAS, the Ohio EPA granted \$50,000 to the Village to renovate the salt storage bin maintained by the Village's Street Department;

WHEREAS, the Village passed Ordinance No. 2024.012 on August 8, 2024 titled "An Ordinance Authorizing The Mayor To Execute The H2Ohio Rivers Chloride Reduction State Grant Award Agreement On Behalf Of The Village Of Blanchester;"

WHEREAS, the Village desires to begin the renovation project as soon as possible in anticipation of the winter season;

WHEREAS, this Resolution is necessary to fund the renovation project until the anticipated grant reimbursement monies are received. This advance from the General Fund will be repaid by February 28, 2025.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council for the Village of Blanchester, Clinton County, Ohio:

**Section 1:** That there be advanced the sum of \$14,400.00 (fourteen thousand four-hundred dollars and no cents) to the H2Ohio Rivers Salt Bin Fund (4201) from the General Fund (1000).

**Section 2:** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of Council, and that all deliberations of the Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

**Section 3:** That this Resolution shall be declared an emergency for necessity of health, safety and welfare of the citizens of the Village of Blanchester and shall be effective on the earliest date allowed by law. This Resolution is being passed as an emergency is due to the imminent winter season.
