

## RESOLUTION No. 2026.025

### A RESOLUTION TENTATIVELY ACCEPTING THE BID OF MILLER BROS. CONST., INC. AS THE LOWEST AND BEST BID FOR THE VILLAGE OF BLANCHESTER RESERVOIR #3 IMPROVEMENT PROJECT AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BLANCHESTER, OHIO:

SECTION 1. The bid of Miller Bros. Const., Inc. of Archbold, Ohio, for the Village of Blanchester Reservoir #3 Improvement Project in the amount of \$ 2,760,292.38, be hereby tentatively accepted, pending approval of Water Supply Revolving Loan Account funding.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare, the particular necessity being the need to submit information to the Ohio Environmental Protection Agency by September 1, 2026.

SECTION 3. That is resolution shall take effect and be in force from and after the earliest period allowed by law.

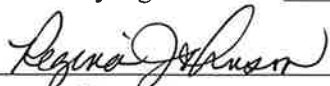
