

RESOLUTION NO. 2020.013

RESOLUTION ESTABLISHING NEW FUND 2907, LEGACY FUND ROOFING GRANT, FOR THE VILLAGE OF BLANCHESTER

WHEREAS, Ohio Revised Code Section 5705.09(F) authorizes the establishment of a fund to account for a new grant whose use is restricted to a particular purpose; and

WHEREAS, the Village of Blanchester has been awarded grant monies by the Clinton County Foundation through the Legacy Fund to be restricted for the use of Municipal Building exterior roofing costs; and

WHEREAS, the Village of Blanchester is required to establish a new fund to track the use of said grant fund monies;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Blanchester, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: The Fiscal Officer of the Village of Blanchester shall establish the following Special Revenue Fund entitled Legacy Fund Roofing Grant using fund number 2907.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including 121.22 of the Ohio Revised Code of the State of Ohio.


