## RESOLUTION GRANTING FISCAL OFFICER AND ANY EMPLOYEE UNDER FISCAL OFFICER'S SUPERVISION PERMISSION TO UTILIZE NEW PROCESS TO STREAMLINE POSTINGS OF GRANT MONIES

**WHEREAS**, the Fiscal Officer for the Village of Blanchester has obtained information and guidance from the Auditors Office and representatives from the Uniform Accounting System, currently utilized by the Village of Blanchester, on a new process to ensure the posting of grant monies in a more efficient manner that would allow for Village of Blanchester to streamline its posting of grant funds; and


**WHEREAS**, the Fiscal Officer for the Village of Blanchester, along with any employee under the direct supervision of the Fiscal Officer, would like permission to utilize this new procedure to allow for the more efficient posting of grant funds by directly paying local match monies from the fund itself and processing a memo receipt in the project fund for the grant monies; and


**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the Village of Blanchester, Ohio, two-thirds or more of the members elected thereto concurring, that Village of Blanchester Fiscal Officer, and any employee under the direct supervision of the Fiscal Officer, is hereby given permission to utilize the new streamlined process for the posting of grant monies through the direct payment of local match monies from the fund itself and processing a memo receipt in the project fund for the grant monies, which this Council finds is a more efficient process and in the best interest of the Village of Blanchester.
