

ORDINANCE NO. 2021.045

AN ORDINANCE ADJUSTING THE SEWER RATES

WHEREAS, the Village of Blanchester, Ohio, Board of Public Affairs has reviewed the operation and maintenance of the Sewer Department, and the required capital improvements which have been completed to date.

WHEREAS, the Board of Public Affairs have recommended to the Village of Blanchester Legislative Authority, an increase necessary to support the operation and maintenance and debt service expenses incurred and now in repayment status.

NOW, THEREFORE the Council of the Village of Blanchester has voted to approve sewer rate schedule, being effective on January 1 of each year as follows:
