

## RESOLUTION NO. 2018.028

### A RESOLUTION ADOPTING RECONSTRUCTION OF DUDLEY ROAD IN CONJUNCTION WITH MARION TOWNSHIP AND PERMITTING APPLICATION TO OHIO PUBLIC WORKS COMMISSION FOR FINANCIAL ASSISTANCE FOR PROJECT

**Be It Resolved** by the Council of the Village of Blanchester, Clinton County, Ohio that the Village Council does hereby apply to Ohio Public Works Commission for financial assistance for a joint project between Marion Township and the Village of Blanchester for the reconstruction of Dudley Road. The full estimated cost for said project is \$369,371.00. The Village of Blanchester and Marion Township combined will provide 11% of the total estimated project cost. The Village of Blanchester will be responsible for 5,085 feet of Dudley Road reconstruction at an estimated cost of \$19,962.09. In the event said project results in any over-run cost in the Village of Blanchester section, the Village of Blanchester would be responsible for additional cost incurred within that section only. See Exhibit A for Engineer's Estimate of Probable Construction Costs for said project.

**Be It Further Resolved** that Greg Heffner, Marion Township Trustee, will file the application on behalf of the Village of Blanchester.


**Be It Further Resolved** that Greg Heffner, Marion Township Trustee, act as the Project Manager and Contact Person on behalf of the Village of Blanchester for said Dudley Road reconstruction project.

**Be It Further Resolved** that the Village of Blanchester's estimated portion of this project, \$19,962.09, will be appropriated from the Permissive Tax Fund (2101).

Full reconstruction of Dudley Road to a full 18 feet wide with 2.5 inch of Asphalt.  
**Total length of Dudley Road: 10,350 feet.**

Based on the upkeep / maintenance / improvement / road agreement.  
**Village of Blanchester is responsible for 5085 feet of Dudley Road.**

**Marion Township is responsible for 5265 feet of Dudley Road (just over 50%).**

**Total project estimate cost: \$369,371.00. Total local funds commitment at 11% = \$40,630.81.  
\$40,630.81 = \$3.926 per foot.**

**Village of Blanchester responsibility = \$19,962.09.**

**Marion Township responsibility = \$20,668.72.**
