

RESOLUTION NO. 2020.022

A RESOLUTION REPEALING RESOLUTION 2020.012 AND ALLOWING THE FISCAL OFFICER TO CREATE NEW FUND 2151, CORONAVIRUS RELIEF FUND

WHEREAS, local governments are required to track the receipt and expenditure activity of the Coronavirus Relief Fund (CRF) distributed pursuant to H.B. 481; and

WHEREAS, on July 28, 2020, Council adopted Resolution 2020.012 to create fund 2052 for said purpose; and

WHEREAS, Uniform Accounting Network (UAN) created fund 2151 in its system for all villages specifically for this purpose and advises this fund number be used for Coronavirus Relief Fund activity tracking purposes;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Blanchester, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: Resolution 2020.012 shall be repealed.



SECTION 2: The Fiscal Officer of the Village of Blanchester shall establish the following in place of the fund formerly adopted by Council: Coronavirus Relief Grant Fund, fund number 2151.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including 121.22 of the Ohio Revised Code of the State of Ohio.
