

RESOLUTION NO. 2026.003

RESOLUTION APPROVING THE ADOPTION OF THE CLINTON COUNTY HAZARD MITIGATION PLAN, NOVEMBER 2025

WHEREAS, the Village of Blanchester recognizes the threat that natural hazards pose to people and property within Clinton County; and

WHEREAS, Clinton County has prepared a multi-hazard mitigation plan, hereby known as the Clinton County Hazard Mitigation Plan; and

WHEREAS, the Clinton County Hazard Mitigation Plan, November 2025 identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in Clinton County from the impacts of future hazards and disasters; and

WHEREAS, adoption by the Village of Blanchester Council demonstrates its commitment to hazard mitigation and to achieving the goals outlined in the Clinton County Hazard Mitigation Plan, November 2025.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Blanchester, Clinton County, Ohio, with at least two-thirds of its members concurring, to adopt the Clinton County Hazard Mitigation Plan, November 2025.

SECTION 1: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including § 121.22 of the Ohio Revised Code.

SECTION 2: This Resolution is hereby declared to be an emergency measure due to time constraints. Following appropriate legislative action, it shall take effect and be in force immediately upon its passage and approval, otherwise it shall take effect and be in force from and after the earliest period allowed by law




