

RESOLUTION NO. 2026.008

A RESOLUTION RENEWING THE CONTRACT WITH HYLANT GROUP FOR LIABILITY INSURANCE COVERAGE AND AUTHORIZING, THE MAYOR TO ENTER INTO AGREEMENT

WHEREAS, the Village of Blanchester is required to maintain adequate liability insurance coverage; and

WHEREAS, the current contract for coverage with Hylant Group is due for renewal; and

WHEREAS, the Village of Blanchester desires to renew the current contract for coverage.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BLANCHESTER THAT: The Village of Blanchester elects to renew the liability insurance coverage contract under the Ohio Plan with Hylant Group not to exceed premium amount of \$ 58,297.00.

SECTION 1: That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including § 121.22 of the Ohio Revised Code.

SECTION 2: This Resolution is hereby declared to be an emergency measure to ensure compliance Due to time constraints with our Renew date being March 1, 2026. Following appropriate legislative action, it shall take effect and be in force immediately upon its passage and approval, otherwise it shall take effect and be in force from and after the earliest period allowed by law


