

# RESOLUTION NO. 2023.016

## RESOLUTION ESTABLISHING NEW FUND 2903, USDA LOAN, FOR PURCHASING VEHICLES, EQUIPMENT AND TECHNOLOGY UPDATES FOR THE POLICE DEPARTMENT, FOR THE VILLAGE OF BLANCHESTER

**WHEREAS**, Ohio Revised Code Section 5705.09(F) authorizes the establishment of a fund to account for a loan whose use is restricted to a particular purpose; and

**WHEREAS**, the Village of Blanchester has received a loan through the United States Department of Agriculture (the "USDA") to be used for the purchase of new vehicles, equipment, and technology for the Police Department, located in the Village of Blanchester, County of Clinton, State of Ohio; and

**WHEREAS**, the Village of Blanchester is required to establish a new fund to track the use of said loan monies;

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Blanchester, Clinton County, Ohio: That the Loan shall be the full general obligation of the Village of Blanchester, and the full faith, credit, and revenue of the Village of Blanchester General Fund, are hereby pledged for the prompt payment of the same.



**Section 1:** The Fiscal Officer of the Village of Blanchester shall establish in the following Special Revenue Fund entitled 2022 USDA Loan and Grant Fund - Police Loan using fund number 2903.

**Section 2:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including 121.22 of the Ohio Revised Code of the State of Ohio.
