

RESOLUTION NO. 2019.036

RESOLUTION AMENDING RESOLUTION 2018.042 BY EXTENDING THE TIME FOR ADVANCE REPAYMENT

WHEREAS, the Village of Blanchester has applied to the Ohio Natureworks Program (ODNR) for financial assistance in the form of a Natureworks grant for the project entitled Dewey's Parking Lot Improvements; and

WHEREAS, Resolution 2018.042 approved by Council on 12/20/18 established Dewey Park Fund 4910 and \$6,439.00 was to be advanced to said fund from the General Fund effective 1/1/19 to be paid back to the General Fund by May 31, 2019;

WHEREAS, in light of the ODNR grant reimbursement process in progress for the Dewey Park Pavilion project, the Council finds it necessary and desirable to extend the time for advance repayment to December 31, 2019 by amending Resolution 2018.042;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Blanchester, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: Said advance repayment is to be extended and is to be paid back to the General Fund by December 31, 2019.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including 121.22 of the Ohio Revised Code of the State of Ohio.
