

RESOLUTION NO. 2019.011

A RESOLUTION TO CONTRACT FOR LEGAL SERVICES ON BEHALF OF THE VILLAGE OF BLANCHESTER

WHEREAS, it is necessary to provide legal services for the Village of Blanchester, and to set compensation;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Blanchester, Clinton County, Ohio:

Section 1: That Peelle Law Office, Co. LPA, (hereinafter "Peelle Law") is contracted to provide legal services for the Village of Blanchester for a two (2) year term commencing April 1, 2019 and ending March 31, 2021.

Section 2: That the Peelle Law provide legal counsel for the Village of Blanchester, the Council, and any department or official of the Village consistent with duties typical of a solicitor including: Reviewing all contracts and other instruments in writing in which the Village is concerned and providing an opinion regarding any doubts concerning the law in any matter before the Council or official in their official capacity; provided however no legal services on behalf of, or relating to, the Village of Blanchester Board of Public Affairs ("BPA") are required under this agreement. Peelle Law reserves the right to subcontract any or all duties necessary to prosecute cases brought before the Clinton County Municipal Court. It is contemplated by the parties that services on behalf the Village BPA will be provided for by separate agreement.

Section 3: Peelle Law shall be paid \$13,600, payable in twelve equal monthly installments.

Section 4: In addition to the salary as stated herein, the Peelle Law shall receive its customary hourly rates when retained by the Village to represent its interest in any civil litigation.

Section 5: This agreement may be terminated by the Peelle Law, without cause and without penalty, upon sixty (60) days written notice.
