A RESOLUTION AUTHORIZING MAYOR JOHN CARMAN TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND / OR LOAL TRANSPORTATION IMPROVEMENT PROGRAM(S) FOR ORCHARD VIEW AND ORCHARD CIRCLE WATER MAIN AND STREET IMPROVEMENTS AND TO EXECUTE CONTRACTS AS REQUIRED

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

WHEREAS, the Village of Blanchester is planning to make capital improvements for the Orchard View and Orchard Circle Water Main and Street Improvements, Phase 2 project and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs,

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BLANCHESTER:

Section 1: Mayor John Carman is hereby authorized to apply to the OPWC for funds as described above.

Section 2: Mayor John Carman is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.
