Discussion Item

Department Reports

Solicitor – The Solicitor reported an update on the wording for the zoning permits on how long the construction time frame should be.

Parks – The Parks has had several events. The had their last Splash Day of the year, movie at the Laurels, National Night Out and Party in the Park.

Police – Chief Houghton went over the July 2025 Police Report. They have done additional training the month and had National Night Out. It was a great event. He also discussed that Tina Fischer had proposed to him of the police department working with their organization to have a local support group for drug overdose/mental health/addiction.

Street – Paul Daniels nothing to report.

BPA – James Bowling reported that they would be having their next meeting at the water plant, to give all residents the opportunity to tour the facility and ask questions. James Bowling also brought up the request to get the KW tax back into the electric fund. James also brought up to council his need to transfer \$500,000 from the Electric Fund to the Water Fund. All legal documents are being prepared to move this money. This money is necessary to keep the water department running with a 6 month carry over of funds.

Zoning/Maintenance – Chris Hilderbrandt nothing to report,

Fiscal Officer – Regina Johnson nothing to report.

Mayor – The mayor reiterated that money received from RITA is 100% going to the Police Department. The only thing we would be looking to do is pull back on the supplemental funds that are taken from the General Fund to help support the Police Dapartment.
