

RESOLUTION NO. 2025.026

2025 SUPPLEMENTAL APPROPRIATIONS

A RESOLUTION to make supplemental appropriations for current expenses and other expenditures of the Village of Blanchester, State of Ohio.

Section 1: Be it resolved by the Council of the Village of Blanchester, State of Ohio, that, to provide for the current expenses and other expenditures of the said Village of Blanchester during the fiscal year, 2025, the following sums be and are hereby set aside and appropriated as follows: See 2025.026 Exhibit A.

Section 2: And the Village Fiscal Officer is hereby authorized to draw warrants for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

Section 3: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality, and shall take effect at the earliest date provided by law. This Resolution must be passed as an emergency due to time constraints.


