<u>Finance Committee</u> – Finance Committee discussed the plan for the Gym renovation, Mr. Hopkins wrote a letter to start the process with the Legacy Fund for a grant to help pay for the renovation in the amount of \$120,000. It was also discussed that the Village and Parks Department would contribute \$15,000 each into the project. Mr. Lee said that after closer investigation the gym will not need a new ceiling which will be a considerable help with the cost, but he is still waiting on estimates on the additional work needed to get the Gym back into usable condition.
