# **Old Business**-

# Village Administrator

The mayor proposed that the council give direction to the solicitor to create an ordinance to hire a village administrator. He asked if there was any discussion. Mrs. Lewis stated she would like the people of Blanchester to speak for themselves.

It was moved by Mr. Hill and seconded by Mr. Garner to allow the solicitor to create an Ordinance to hire a Village Administrator

The solicitor stated the ordinance would have to be voted on again.

The mayor mentioned that the salary of the village administrator would have to be decided upon, and how we should draft it. All budgets will be affected except for the police department. Mr. Hopkins noted that it should be drafted from the general fund, which can be edited. Mrs. Lewis questioned whether we are going to be able to find a village administrator for less than the board.

The solicitor recommends that the amount needs to be identified and where it is coming from. Mr. Hopkins stated he wasn't sure, but it was between \$60k-\$130k.

#### **Department Reports**

**Solicitor** – The Solicitor had nothing to report.

Parks – Paul Jackson invited everyone out to the Bluegrass Festival

**Police** – Mayor reported for Chief Houghton that K-9 training starts next week. The drones have been ordered. Officer Smith completed field training classes for FTO. On Saturday, October 25, there will be a Drug Take Back Day at Kroger's. They raised \$3k for Shop with a Cop, and donations can still be made at the office.

**Street** – Nothing to report.

BPA – James Bowlings thanked Chris Hilderbrandt for accommodating the BPA by setting up the council chambers and equipment for their meeting. He shared good news about the transformers that were voted on for the substation project. Ram Reddy, our director of utilities, negotiated for an additional discount that increased from 1.5% to 3% which totaled \$85k in savings. Ram and Rusty Hampton met with AMP Ohio and other municipal electricity organizations to discuss the financing of substations. The next BPA meeting is on October 16, 2025, at 7:00 p.m. in the BPA conference room.

## Zoning/Maintenance -

Can you give an update on the nonconforming properties? One owner stated he would have the property cleaned by the deadline. The mayor asked what happens after 28 days. Solicitor stated there would be a case management meeting with the judge, the property owner, and himself. A hearing would take place, and if he doesn't respond within the 28 days, then it is called a default. A motion for default judgment to secure an order against the property owner, then a contempt court motion so someone can assess all costs against the property.

The mayor shared that Chris is continuing the paint the back stairway.
