

ORDINANCE NO. 2022.019

2022 SUPPLEMENTAL APPROPRIATIONS

A RESOLUTION to make supplemental appropriations for current expenses and other expenditures of the Village of Blanchester, State of Ohio, during the fiscal year ending December 31, 2022.

SECTION 1: Be it resolved by the Council of the Village of Blanchester, State of Ohio, that, to provide for the current expenses and other expenditures of the said Village of Blanchester during the fiscal year ending December 31, 2022, the following sums be and are hereby set aside and appropriated as follows:

SECTION 2: And the Village Fiscal Officer is hereby authorized to draw warrants for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 4: This Resolution is declared to be an emergency measure necessary to preserve the health, safety and welfare of the residents of the Village of Blanchester, Ohio and shall become effective immediately upon its adoption.

SECTION 5: That the Village by at least a three-fourths vote hereby dispenses with the requirement that this Resolution be read on three separate days and hereby authorizes the adoption of the Resolution upon its first reading. That this Resolution shall be effective at the earliest date allowed by law.


