

ORDINANCE NO. 2024.004

2024 PERMANENT APPROPRIATIONS

An ORDINANCE to make PERMANENT appropriations for current expenses and other expenditures of the Village of Blanchester, State of Ohio, during the fiscal year ending December 31, 2024.

Section 1: Be it resolved by the Council of the Village of Blanchester, State of Ohio, that, to provide for the current expenses and ordinary expenditures of the said Village of Blanchester during the fiscal year until December 31, 2024, the following sums be and are hereby set aside and appropriated as follows: Attached Exhibit 2024.004 A.

Section 2: And the Village Fiscal Officer is hereby authorized to draw warrants for payments from any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an ordinance or resolution of Council to make the expenditures provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinance. Provided further that the appropriations for contingencies can only be expended upon appeal of two-thirds vote of council for items of expense constituting a legal obligation against the Village, and for purposes other than those covered by other specific appropriations herein made.

Section 3: This Ordinance shall take effect at the earliest period allowed by law.
