

RESOLUTION NO. 2018.042

RESOLUTION ESTABLISHING NEW FUND 4910, DEWEY PARK, FOR THE VILLAGE OF BLANCHESTER & DECLARING IT NECESSARY TO ADVANCE \$6,439.00 TO SAID FUND FROM THE GENERAL FUND EFFECTIVE 1/1/19

WHEREAS, the Village of Blanchester has applied to the Ohio Natureworks Program (ODNR) for financial assistance in the form of a Natureworks grant for the project entitled Dewey's Parking Lot Improvements; and

WHEREAS, Ohio Revised Code Section 5705.09(F) authorizes the establishment of a fund to account for a new grant whose use is restricted to a particular purpose;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Blanchester, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: The Fiscal Officer of the Village of Blanchester shall establish the following Capital Project Fund: Dewey Park using Fund number 4910 effective 1/1/19.


SECTION 2: Advance is to be paid back to the General Fund by May 31, 2019.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all the deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements including 121.22 of the Ohio Revised Code of the State of Ohio.
