<u>Finance Committee</u> – Mr. Gephart stated that he is looking into other avenues for better interest rates on our CD's and Bonds. He is looking into STAR (State Treasury Asset Reserve) of Ohio they are associated with the Treasurer of State for Government and Municipal entities.
