

# RESOLUTION NO. 2019.016

## RESOLUTION AUTHORIZING FISCAL OFFICER TO MAKE OPWC LOAN CJ16S REPAYMENTS FROM CENTER MAIN PROJECT FUND 4906 UNTIL FULLY EXPENDED AND THEREAFTER RESUME REPAYMENT FROM PERMISSIVE FUND 2101

**WHEREAS**, the Village of Blanchester completed the Center/Main Street Improvements Project; and

**WHEREAS**, OPWC Loan CJ16S was incurred to assist with the completion of the Center Main Project and Village of Blanchester Resolution 2014.023 initially resolved by Village Council for said loan to be repaid via the Permissive Tax Fund 2101; and

**WHEREAS**, pursuant to ORC 5705.14(B) the unexpended balances in permanent improvement funds are to be used for payment of all obligations incurred in the acquisition of such improvement; and

**WHEREAS**, Fund 4906, Center Main Project Fund, contains an unexpended cash balance; and


### **NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BLANCHESTER THAT:**

The Village of Blanchester Council authorizes the Fiscal Officer to repay OPWC Loan CJ16S from Center Main Project Fund 4906 until all remaining cash balance in said fund has been fully expended. At such time, repayment of CJ16S will resume from Permissive Fund 2101.
