# ORDINANCE TO AMEND ORDINANCE 2021.013 TITLED "AN ORDINANCE TO ESTABLISH BENEFITS FOR EMPLOYEES RESPONSIBLE FOR THE SAFETY AND SECURITY OF THE CITIZENS OF THE VILLAGE OF BLANCHESTER"

WHEREAS, the Village of Blanchester passed Ordinance No. 2021.013 to offer a Longevity Payment Program and Educational Payment Program for Police Officers; and

WHEREAS, the current provisions set forth in Ordinance 2021.013 are no longer in the best interest of the Village of Blanchester ("Village"); and

WHEREAS, the Village desires to amend Ordinance No. 2021.013 pursuant to Ohio Revised Code Section 731.19; and

**NOW THEREFORE BE IT RESOLVED**, by the Council of the Village of Blanchester, Clinton County, Ohio that:

#### **SECTION 1.**

Ordinance 2021.013 is hereby amended as shown in the attached Exhibit A. The remaining portions of Ordinance 2021.013 remain in effect.

#### **SECTION 2.**

The Village finds and determines that all formal actions of this Village concerning and relating to the adoption of this Ordinance were taken in an open meeting of the and that all deliberations of this Village that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements.

#### **SECTION 3.**

This Ordinance shall be read three times and shall be in full force and effect from and after the first date provided by law. This requirement may be suspended by a three-fourths vote of council.

## ORDINANCE NO. 2021.013

### AN ORDINANCE TO ESTABLISH BENEFITS FOR EMPLOYEES RESPONSIBLE FOR THE SAFETY AND SECURITY OF THE CITIZENS OF THE VILLAGE OF BLANCHESTER

WHEREAS, the Village of Blanchester believes that it is within the best interest of its citizens to offer a Longevity Payment Program and Educational Payment Program for Police Officers who serve and protect the citizens of the Village of Blanchester; and

WHEREAS, the Village of Blanchester recognizes the importance of retaining skilled, experienced police officers to remain employed with the Village of Blanchester for its citizens safety and security during an increasing national shortage of certified police officers; and

WHEREAS, the Village of Blanchester recognizes the importance of attracting skilled and trained police officers to its employment for the health, safety and well-being of its citizens; and

# NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BLANCHESTER, OHIO THAT:

SECTION ONE: The Council for the Village of Blanchester creates the Blanchester Police Longevity Payment Program. Any Village police officer who, as of June 1, 2021, has been employed by the Village of Blanchester in a full-time capacity, whether temporary or permanent, for three (3) consecutive years, shall receive longevity pay in the amount of \$1,500, payable on or before July 1, 2021. Thereafter, each Village police officer shall receive longevity pay in the amount of \$1,000 upon completion of each additional three (3) year period of full-time employment, payable within 30 days of the 3-year anniversary date of that Village police officer.

SECTION TWO: The Council for the Village of Blanchester creates the Blanchester Police Educational Payment Program. Any Village police officer who is hired by the Village, on or after January 1, 2021, and who is employed by the Village in a full-time or part-time capacity for twenty-four (24) thirty-six (36) consecutive months shall receive a one-time payment to reimburse up to fifty percent (50%) of the Village police officer's tuition costs of basic certification training up to Three-Thousand Five Hundred Dollars and No Cents (\$3,500.00). Village police officer shall not be eligible for this provision should employment with the Village of Blanchester end prior to the end of the required 24-month period.
